DECLARATION OF EMERGENCY

WHEREAS, the World Health Organization has declared the COVID-19 outbreak a pandemic, Governor Cuomo has declared a New York State of Emergency and President Trump have declared a National Emergency.

WHEREAS, the Government of Clinton County, NY has declared a State of Emergency and the Town of Mooers will continue to work together with our partners in local, state and federal government; and

WHEREAS, Northeastern Central School District (NCCS), and Northern Adirondack Central School District (NACS) both lie within our municipal boundaries; and

WHEREAS, all Town of Mooers Departments and Employees shall enact emergency plans and take appropriate action to contain, respond to and recover from this emergency; to protect property and to provide other assistance as it may be deemed necessary to protect health, welfare, and safety, without Town Board approval provided authorization is granted by the Chief Executive Officer and/or the Highway Superintendent Officer of the Town of Mooers.

WHEREAS, Any Town of Mooers local laws, rules, regulations or resolutions may be temporarily suspended or modified if compliance with such would prevent, hinder or delay action necessary to cope with the emergency or, if necessary to assist or aid in coping with such disaster/pandemic outbreak.

WHEREAS, the Town of Mooers asks our citizens to be vigilant in combating COVID-19 with social distancing, increased hygiene protocol, adherences to best practices from health officials, and implement directives from federal, state, and local officials; and


BE IT RESOLVED, as Chief Executive of the Town of Mooers, I, Jeff L. Menard, exercise the authority vested to me under Section 24 of the New York State Executive Law, to preserve the public safety and hereby render all required and available assistance vital to the security, wellbeing, and health of the citizens of the Town. I hereby direct all departments and agencies of the Town of Mooers to take whatever steps necessary to protect life, property, public infrastructure, and provide such emergency assistance as deemed necessary to protect all vital services.
