The Special Meeting and Regular Meeting of the Mooers Town Board was held on May 10,2011 at the Mooers Office Complex in Mooers.

<u>Present:</u> Those present for the Meeting were Supervisor Rudolph Miller, Councilman Earl Robinson, Councilman Steve Barcomb, Councilman Steve Barcomb, Councilman Eugene Bushey, Councilman Gerald LaValley, Highway Superintendent Eugene (Dick) Boulerice and Susan Miller in place of Town Clerk/Tax Collector Shirley A Gadway.

<u>In Attendance</u>: Those attending the Meeting were: John Farley (Accessibility Consultant of North Country Center for Independence), Librarian (Jackie), Library Association Staff (Susan Evans, Lynn DeCoste, Sharon Duchaine, Katie Evans, Edie Morelock, Gloria Lafountain, and Mr. & Mrs. Arthur Menard), and Fire Chief Raymond Phair.

<u>Special Meeting</u>: Supervisor Miller called the Special Meeting to order at 6:00 PM, then he asked Susan Miller to lead them in the "Pledge of Allegiance" which she did.

John Farley: Mr. Farley was at the Meeting to offer suggestions and answer any questions regarding handicap accessibility for the Library, making the playgrounds handicap accessible and any other issues related to handicap accessibility. LIBRARY: Some of John Farleys' ideas were 1) provide quotes and write up an action plan for the next 5 years showing ability to obtain equipment as it becomes available 2) suggested the building be checked for asbestos and lead 3) should notify United Way of our needs so if and when they receive equipment which we could receive for FREE or at an affordable price we would be notified as waivers end in March 2012 4) the bathroom meets handicap accessibility size wise but shelves and sink need to be moved also Children's section need a chair lift or elevator 5) both floors must be handicap accessible unless downstairs is not considered a public area 6) If the downstairs is used as a reading area and accommodations are made for youth upstairs this must be posted in the upstairs area 7) there must be 1 handicap accessible parking for every 25 spaces, and there should be a sign for van accessibility, also a van cannot unload or load on street side. Parking should be as close to the building as possible. There should also be a van parking space on Town Parking Areas 8) John Farley prefers the lift over the ramp maintenance wise as well as cost wise. 9) Mr. Farley was asked if the Town owns the Library but the Association runs it to whom does responsibility belong to. He believes the Town would be responsible. He said an ADA should be responsible for decisions on the Library with the Association. He said make sure an agreement is in place in writing. He said there has been an agreement between Champlain and Rouses Point to accommodate wheel chair needs for our area (affects 1 child at this time). 10) As for the playgrounds Mr. Farley suggested if you are not being bothered at this time leave it alone.

Mr. John Farley gave Supervisor Miller a number where he can be reached. He said when the Town has their comprehensive plan include pictures, reports and any quoted. Mr. Farley will be at the June 20,2011 meeting at 9:30 in Plattsburgh to meet with ALL the Library personnel in the area. Also Katie Evans volunteered to help with the 5 year plan and left a number to reach her at.

Meeting: Supervisor Miller officially started the Regular Meeting at 7:00PM.

<u>Minutes:</u> There were 2 corrections to be made to the Minutes. Atlantic City had to be changed to Las Vegas and Flight Flight had to be corrected to Life Flight. Councilman Bushey made a motion the minutes be accepted as written with the two corrections made and Councilman Barcomb seconded the motion. The result of a Roll Call was 5 AYES (Supervisor Miller, Councilman Robinson, Councilman Barcomb, Councilman Bushey and Councilman LaValley) and 0 NOES. Thus Supervisor Miller declared minutes accepted as written.

<u>Meeting for Local Law #2-2011</u>: Before a Local Law can be adopted a public hearing must be had giving the public time to approve or oppose it. Councilman Barfcomb made a motion the following resolution be adopted

Councilman Bushey seconded the motion and the result of a Roll Call was 5 AYES (Supervisor Miller, Councilman Robinson, Councilman Barcomb, Councilman Bushey and Councilman LaValley and 0 NOES. Therefore Supervisor Miller declared **Resolution #23-2011** is adopted.

Adopting Local Law #2-2011: An Advertisement in the Legal Section of the Press Republican appeared on April 30, 2011 that there would be a Public Hearing on May 10,2010 at 8:00PM. After everyone expressed their opinions at the Public Hearing Councilman Bushey made a motion the following resolution be adopted

<u>Purebred Puppies:</u> Sometimes people who own Purebred Dogs\_with puppies under 1 year old that they are selling. These puppies are listed on the Purebred License but are un-named as once a registered purebred is named it must keep that name for life. Councilman Bushey made a motion the following resolution be adopted

Councilman LaValley seconded the motion and the result of a Roll Call was 5 AYES (Supervisor Miller, Councilman Robinson, Councilman Barcomb, Councilman Bushey and Councilman LaValley) and 0 NOES. Thus, Supervisor Miller declared **Resolution #25-2011** is adopted.

<u>Regular Meeting:</u> At 8:15 the Regular Meeting resumed.

<u>Examine Court Records and/or Dockets:</u> Once a year the books of the Court System must be examined by the Town Board. At the May 10,2011 Board Meeting the Court books were examined and Councilman Robinson made a motion the following resolution be adopted

Councilman Barcomb seconded the motion and result of a Roll Call was 5 AYES (Supervisor Miller, Councilman Robinson, Councilman Barcomb, Councilman Bushey and Councilman LaValley) and 0 NOES. Therefore Supervisor Miller declared **Resolution #26-2011** is hereby adopted.

<u>Accept Audit and/or Examination Justice Court Records and/or Court Dockets:</u> Section 2019-a of the Uniform Justice Court requires that the Court Records and/or Dockets be examined, accepted and included in Minutes. At the May 10,2011 Meeting Councilman LaValley made a motion the following resolution be adopted

<u>Highway Department:</u> Highway Superintendent Boulerice said the Bush Rd., Scriver Rd., St. John's Rd. and Howard Rd sustained flood damage. He is going to apply to FEMA with the flooding issues. He reported The Town received the CHIP money (the same as last year). Dick said he is still waiting to hear on the SALT news and they are also waiting on their permit for the Quarry.

<u>Rabideau property on St. John's Rd.</u>: Received a letter from Rabideau's lawyers requesting more time be given to the Rabideau's to complete their home. As per the Zoning the Zoning has no authority to extend them more time. An option for them would be to let a Judge decide as he has the authority to grant the extension. The Rabideau's are no longer accepting phone calls from the Town.

<u>LaBarge Agency</u>: The Town received a letter regarding safety courses workers can take to help lower Workers Compensation. Towns can get together and share the expenses of having these safety courses.

<u>Clinton County Office of Emergency Services:</u> Received a fax explaining different agencies and ways to handle a disaster and where to seek help. It's best if communities join together.

<u>Library:</u> All the Town of Mooers Board received an invitation to attend the Annual Meeting on Wednesday May 18, 2011 at 6:00PM at the Library. Councilman Robinson and Councilman LaValley are planning on attending.

<u>Uniforms:</u> The Uniform slips from last month's meeting were re-submitted and signed by the Board Members.

<u>Hand Book:</u> Councilman Robinson has been studying a hank book out of Connecticut. He told the Board he thinks it will take a lawyer to fine tune the wording for our handbook.
